#### **Letter from the President**

#### Dear Friend of the Foundation:

Each year I take great pride in sharing with you the myriad ways the Bloomington Hospital Foundation has had an impact on our local community – and 2016 is no exception. As you'll see on the Financials page of this report, together this community helped us raise \$1.9 million. And thanks to your generosity, we were able to allocate \$1.34 million in support of local healthcare throughout 2016.

Raising money can be hard work; in our community, raising money can also be a lot of fun. The spring of 2016 was no exception when we held 100 Men Who Cook in partnership with Old National Bank. That event raised a record \$120,000 split between G.O.A.L. (Get Onboard Active Living) and our local Meals on Wheels. The fall gave us another successful Hoosiers Outrun Cancer which raised over \$200,000 for the IU Health Olcott Center. And the year culminated in the annual Gala, a beautiful "Evening in the Garden" that raised \$120,000 for the Hospital's Greatest Need fund – likely in support of the future hospital.

I'm always a fan of our "big campaigns" but I think it's also important to note some of the smaller expenditures that truly make an impact on local patients and families. In 2016 these included (but are not limited to):

- Modems in Ambulances

Regarding big campaigns, I'd like to update you on the 2014 Trauma Services Campaign. As I shared with you last year, thanks to your support, crucial equipment is in place and in use. The hospital had its initial consultative visit toward becoming a Level III Trauma Center in 2015 and a verification visit just this spring. In May of this year, the hospital received Level III Verification and is the only trauma center in our region. So although this annual report shares 2016 successes, I would be remiss not to share with you this news that has just occurred in 2017!

Speaking of 2017, we're celebrating our 50th year this year. Again, not technically a 2016 report-out, but important to share none-the-less. And since we're forward-looking, I'll briefly touch on the new IU Health Bloomington Hospital build. The role of philanthropy has not yet been determined – but make no mistake, it will be important and it will likely be the largest undertaking of the Bloomington Hospital Foundation. I look forward with great excitement and anticipation to the local "stamp" the Foundation – with your support – will be able to put on the new hospital campus.

As I close, I'd like to draw your attention to our logo. Toward the end of 2016, we updated our tagline to "Impact Local Healthcare." It says a lot about what we are able to do with your generous support. That's really what it's all about – making a positive impact on the lives of those in our local community. As always, thank you for your continued support of the Bloomington Hospital Foundation. I look forward to partnering with you to create an even stronger IU Health Bloomington Hospital for the people of Bloomington and south central Indiana.





## **Corporate Giving Making an Impact**

### Focus on: Bunger & Robertson

It was the late 1940s when local attorney Len Bunger first began legal representation of Bloomington Hospital. Healthcare and law was much different then...he represented the hospital for free in exchange for medical care. His children were born at the hospital without charge in return for legal services provided by Len. Fast forward nearly 70 years, and though Len is deceased, Bunger & Robertson still provides legal services to IU Health Bloomington Hospital.



And the firm, knowing the benefit of good, local healthcare, gives back to the hospital via the Bloomington Hospital Foundation. "Our relationship with the Bloomington Hospital Foundation has been the primary way for us to support the hospital and healthcare in Bloomington and the surrounding communities," said Jim Whitlatch, Partner, Bunger & Robertson. "Strong local healthcare is critical on many different levels."

Jim continued by explaining the impact our local hospital has had on himself, his family, his employees and the community at large. "I personally have had three children who were born at IU Health Bloomington Hospital. I've also spent time there as a patient," he said. Jim also noted the significance of the hospital as it ties to the economy of the community. "Having a strong hospital and healthcare system is critical to enticing businesses and residents," he explained. "You never see a survey of great places to live or great locations to retire without a significant mention of the healthcare available in that community.

"Supporting the Bloomington Hospital Foundation is one of the most important things we can do both as individuals and as businesses."

Bunger & Robertson generally chooses to give to the Hospital's Greatest Need. "We do not have a specific cause," he said. "We trust the Foundation to understand the hospital's needs, and we are supportive of having our contributions go to where there is the greatest need."

The local law firm sponsors Hoosiers Outrun Cancer, the annual Gala and 100 Men Who Cook (since its inception). Jim personally supports the Foundation via the Heritage Society. Not only is his law firm a Foundation Corporate Partner, but the employees of Bunger & Robertson are also active in the Foundation. Several of the firm's 30+ employees participate in Hoosiers Outrun Cancer each year. Some have served on the Foundation board. Many are individual donors.

"A strong hospital supported by a strong local Foundation is critical to both the physical and economic health of the Bloomington community," Jim stressed. "I would encourage local businesses to consider healthcare as a cornerstone of a robust community. 
