# From our President & CEO

After 50 years of operating as the sole philanthropic agent of Bloomington Hospital, late last year the Bloomington Hospital Foundation's Board of Directors voted to focus more specifically on the community health aspect of its mission and thus charted a new course for the organization. As part of this vote, the board affirmed its independence as a locally-controlled. independent non-profit and acknowledged the significant work that is before us regarding the health of our community. It's no secret that we, as do many communities across our state and country.

have significant opportunities to improve our overall health. Our name may be new, but you know our faces and our determination. You know this because we're you and we're in this movement to create a healthier community together.

During this past year, our FIRST year as the newly-renamed Bloomington Health Foundation, we've learned a lot and we still have lots of learning to do. One thing we have learned is that defining health is tough. For one person it's being physically fit and eating well. For another, it's simply hoping for a ride to seek treatment or enough money to afford medicine. We've seen and heard the struggles our neighbors face when poor living conditions, lack of food and rising health costs make things seem hopeless. We've also seen how a community that reaches out to lend a hand both physically and financially can make someone's life a little better...a little healthier. While every community has its challenges, ours belong to us. We know them. We see them. We live them.

In our first year we made targeted and significant investments aimed at many of our community's most pressing health needs: augmenting mental health access, improving substance use disorder recovery. improving healthcare access for the medically-underserved. improving infant mortality rate, and supporting those fighting cancer through our annual Hoosiers Outrun Cancer. We've partnered with local organizations including Monroe County United Ministries. Catholic Charities, City of Bloomington, Bloomington Parks Foundation, Volunteers in Medicine, Monroe County Health

Department, Susie's Place, Centerstone, YMCA of Monroe County, Owen County Family YMCA, Monroe County Community School Corporation, Richland-Bean Blossom Community School Corporation, New Hope Family Shelter, Local Council of Women, IU School of Medicine, Hospice House, Children's Therapy Center and IU Health Bloomington.

The Foundation's expanded community health focus also affords us the opportunity to provide cross-sector leadership and collaboration in addressing our community's health needs. Earlier this year the Foundation partnered with the Greater Bloomington Chamber of Commerce to present Dr. Jennifer Walthall, Secretary of Indiana's Family and Social Services Administration, and a local panel to discuss community response efforts to substance use disorder. We also sponsored the 2nd South Central Opioid Summit and again, partnering with the Chamber, are sponsoring a four-part opioid response series titled "Opioid Solutions for Our Business Community."

The Bloomington Health Foundation stands with you. Our longstanding history, local connection, and proven ability to solve health problems encourages us to be a leader in creating a movement that prioritizes solving local health concerns to create a stronger, more vibrant community. We believe that targeted, philanthropic health-related giving is critical towards obtaining the goal of a healthier life for all of us, at every stage in our lives. We look for others who share our passion, who are willing to tackle the tough challenges with us and who believe that standing together is the way to change our community for the better.

# **IUSM Scholarship Recipient**

The 2018 recipient of the Indiana University School of Medicine & Bloomington Health Foundation Scholarship is Michael Miller. In 2013, we made a \$100,000 gift to permanently endow this scholarship, with Indiana University Foundation partnering to match the gift.

BHF President and CEO, Jonathan Barada, awarded Miller the scholarship at the School of Medicine's annual banquet adding, "The mission of the Bloomington Health Foundation is to invest philanthropic support in partnership with the people and organizations of our community to work towards solutions to our community's health concerns. According to a

recent study, Indiana will need 817 more primary care physicians by 2030. The spirit behind this scholarship is to support students from our community who want to become physicians with the hope they will return home to practice. We're honored to partner with the IU School of Medicine to provide this scholarship to Michael."

Each year the scholarship is given to a 4th year medical student who graduated from high school in a South Central Indiana county. Miller is a Jennings County High School graduate and is the sixth recipient of this award. He intends to practice primary care in a rural setting near Bloomington.
